TERMS AND CONDITIONS

- 3. The prize is not inheritable, for sale, and may not be transferred, exchanged and/or redeemed for cash.
- 4. The entrant is responsible for all costs which he or she incurs in connection with entry in the Promotion. Similarly, the winner and their accompanying person will be responsible for any costs not included in the description of the prize which he or she incurs.

PARTICIPATION AND WINNER SELECTION

- 5. The Competition will be held at the following BOSS and HUGO stores (hereinafter BOSS stores referred to as "Participating BOSS Store(s)" and HUGO stores referred to as "Participating HUGO Store", BOSS and HUGO stores together referred to as "Participating Stores") and in the HUGO BOSS online store (www.hugoboss.ae) from November 29, 2025 (10:00 AM, AST) to December 3, 2025 (10:00 PM, AST) (hereinafter referred to as "Promotion Period"):
 - a. Participating BOSS Store(s)
 - BOSS Store, Dubai Mall, Fashion Avenue, Dubai
 - BOSS Store, Palm Jumeirah Mall, Dubai
 - b. Participating HUGO Store
 - HUGO Store, YAS Mall, Abu Dhabi

Entries submitted outside the Promotion Period will not be accepted by HUGO BOSS.

6. In order to enter the Competition, each participant must meet the following conditions:

a) For in-store purchases:

<u>BOSS Store</u>: Any customer that registers for the HUGO BOSS EXPERIENCE Program in-store or is already a registered member and makes a purchase of a minimum of 1,000 AED (in words: one thousand Arab Emirates Dirham), incl. taxes, during the Promotion Period in a directly operated brick-and-mortar BOSS Store in the UAE (https://hugoboss.ae/locate-us) must follow the steps outlined in *c*).

<u>HUGO store</u>: Any customer that registers for the HUGO BOSS EXPERIENCE Program in-store or is already a registered member and makes a purchase of a minimum of 500 AED (in words: five hundred Arab Emirates Dirham), incl. taxes, during the Promotion Period in a directly operated brick-and-mortar HUGO Store in the UAE (https://hugoboss.ae/locate-us) must follow the steps outlined in *c*).

OR

b) For online purchases:

Any customer with an online account on www.hugoboss.ae who makes a minimum online purchase of 1,000 AED (in words: one thousand Arab Emirates Dirhams) during the Promotion Period on www.hugoboss.ae must visit one of the Participating Stores during the Promotion Period and register for the HUGO BOSS EXPERIENCE Program or confirm their existing membership and must follow the steps outlined in *c*).

Customers must show proof of their online order and confirm that the purchase meets the minimum required amount.

c) Final Step for All Participants:

Complete the registration form at the car racing simulator by providing all necessary information (e.g. Customer ID)*.

Play on the car racing simulator in the Participating Store, while following these game rules:

- i. Each participant will have a total of seven (7) minutes on the car racing simulator to achieve their best lap time.
- ii. Participants may complete as many laps as possible within the allocated time. If a participant exceeds track limits (e.g. cutting corners), the game will automatically void the lap times where these limits have been breached.
- iii. Participants who achieve a lap time of 1:35 minutes or faster will instantly win the following rewards, subject to availability:
 - 1. In Participating BOSS Stores: An Aston Martin LEGO car.
 - 2. In Participating HUGO Store: A VCARB LEGO car.

*Participants must ensure that the data entered is accurate, as incorrect information may prevent HUGO BOSS from matching participants' details, potentially affecting the ability to claim any prizes.

- 7. There will be a total of 6 (six) winners: Three winners will be selected from the Participating HUGO Store, and three winners will be selected from the two Participating BOSS Stores. For the HUGO Store, the three fastest participants based on their lap times in the car racing simulator will be determined for the first, second, and third places. For the BOSS Stores, the lap times from both stores will be combined, and the three fastest participants across both stores will be determined for the first, second, and third places. Winners will be selected based on their lap times at the end of the Promotion Period.
- 8. The winners of each placement will be notified by HUGO BOSS on December 4, 2025 from 10:00 AM via phone call, WhatsApp and email.

Emails will be deemed to be received on the date of transmission; communications sent by post will be deemed to be received 5 days after posting. Proof of submitting an entry is not proof of HUGO BOSS's receipt.
- 19. HUGO BOSS accepts no responsibility for technical or other disturbances, including those resulting from the breakdown of its network, the website, computer etc. which make entry to the Competition impossible.
- 20. HUGO BOSS gives no warranties or representations about the quality or suitability of any prize.
